It is adjudged that the defendant has been convicted on the following count(s):

**Count 1 : Driving Under the Influence of Intoxicants - Diversion Eligible**

Count number 1 , Driving Under the Influence of Intoxicants - Diversion Eligible, 813.010(4), Misdemeanor Class A, committed on or about 11/23/2010. Conviction is based upon a No Contest Plea on 11/10/2011.

- Not drive without valid permit, license and insurance.
- Obey all laws.
- Abstain from the use of intoxicants; do not consume or possess alcohol or non-prescribed controlled substances
- Enter and successfully complete alcohol/drug treatment as deemed appropriate by probation officer. Report to Jackson County Community Justice, 1101 West Main, Medford, OR 97501.
- Submit to random breath and urine testing if lawfully requested by a police officer.
- Attend Victims Impact Panel or an equivalent within two months.
- Complete 80 hours of community service. Immediately report to Jackson County Community Justice, 1101 West Main, Medford, OR 97501.
