It is adjudged that the defendant has been convicted on the following count(s):

Count 1 : Assault-3

Count number 1 , Assault-3, 163.165(2A), Felony Class C, committed on or about 07/22/2011. Conviction is based upon a Guilty Plea on 10/17/2013.

Sentencing Guidelines

Probation

Defendant is sentenced to Supervised Probation for a period of 3 year(s) and shall be subject to the following conditions of Probation:

Defendant is subject to all general conditions of probation (ORS 137.540).

Furthermore, Defendant is subject to the following Special Conditions of Probation (ORS 137.540(2)):
Defendant shall:

- Obey all laws.
- Comply with all conditions and procedures of accounting office regarding payment of fines, restitution and fees imposed. Abide by the financial conditions of probation document furnished to you by the court, probation officer or Department of Justice collection agent.
- Attend and participate with any counseling deemed appropriate by probation officer.
- Name: Marina McDonald Not have contact with victim (except for pending civil litigation) without prior permission from the court.
- Pay restitution in an amount to be determined as ordered and pursuant to ORS 137.106(b). COURT EXTENDS TIME TO DETERMINE RESTITUTION TO 6 MONTHS. Defense stipulates the State does not need to detail the nature and amount of economic damages at this time.
- Supervised Probation: Report immediately to Jackson County Community Justice, 1101 West Main, Medford, OR 97501 within 24 hours of your sentencing unless you are in custody. If in custody, report within 24 hours of your release from jail.

Pursuant to the sentencing guidelines grid, the Defendant is subject to 90 sanction units with 30 jail units.

Jail as a Condition of Probation

Defendant is confined to jail for 30 day(s). Defendant is to report to Supervisory Authority by 11/04/2013 at 9:00 AM. Defendant may receive credit for time served.

The Defendant may be considered by the supervisory authority for any form of alternative sanction authorized by ORS 423.478, and the defendant shall pay any required per diem fees.

- Comply with all conditions and procedures of accounting office regarding payment of fines, restitution and fees imposed. Abide by the financial conditions of probation document furnished to you by the court, probation officer or Department of Justice collection agent.
- Not drive without valid permit, license and insurance.
- Obey all laws.
- Abstain from the use of intoxicants; do not consume or possess alcohol or non-prescribed controlled substances
- Enter and successfully complete alcohol/drug treatment as deemed appropriate by probation officer. Report to Jackson County Community Justice, 1101 West Main, Medford, OR 97501.
- Submit to random breath and urine testing if lawfully requested by a police officer.
- Attend Victims Impact Panel on 11-6-13

Jail as a Condition of Probation

Defendant is confined to jail for 10 day(s). Defendant is to report to Supervisory Authority by 11/04/2013 at 9:00 AM. Defendant may receive credit for time served.

The Defendant may be considered by the supervisory authority for any form of alternative sanction authorized by ORS 423.478, and the defendant shall pay any required per diem fees.
