It is adjudged that the defendant has been convicted on the following count(s):

**Count 1 : Theft in the First Degree**

Count number 1 , Theft in the First Degree, 164.055, Felony Class C, committed on or about 07/01/2011. Conviction is based upon a Guilty Plea on 01/31/2014.

**Sentencing Guidelines**

The Crime Severity Classification (CSC) on Count Number 1 is 1 and the Criminal History Classification (CHC) is I.

**Probation**

Defendant is sentenced to Supervised Probation for a period of 18 month(s) and shall be subject to the following conditions of Probation:

Defendant is subject to all general conditions of probation (ORS 137.540).

Furthermore, Defendant is subject to the following Special Conditions of Probation (ORS 137.540(2)): Defendant shall:

- Obey all laws.
- Pay restitution in an amount to be determined as ordered and pursuant to ORS 137.106(b). Defense stipulates the State does not need to detail the nature and amount of economic damages at this time.
- Complete 80 hours of community service. Immediately report to Jackson County Community Justice, 1101 West Main, Medford, OR 97501.
- Not have contact with victim, Ashley Tavares and/or Rays Food Place, without prior permission from the court.

Pursuant to the sentencing guidelines grid, the Defendant is subject to 90 sanction units with 30 jail units.

## **COUNTS DISPOSED WITH NO CONVICTION**

Count # 2 , Identity Theft is Dismissed.

Count # 3 , Forgery in the First Degree is Dismissed.
