It is adjudged that the defendant has been convicted on the following count(s):

**Count 4 : Wildlife Violation**

Count number 4 , Wildlife Violation, 498002, Misdemeanor Unclassified, committed on or about 02/12/2012. Conviction is based upon a Guilty Plea on 02/12/2014.

**License Suspension / Revocation**

Defendant's Hunting License is Revoked for Life.

**Probation**

Defendant is sentenced to Bench Probation for a period of 18 month(s) and shall be subject to the following conditions of Probation:

Defendant is subject to all general conditions of probation (ORS 137.540).

Furthermore, Defendant is subject to the following Special Conditions of Probation (ORS 137.540(2)): Defendant shall:

- Obey all laws.
- Comply with all conditions and procedures of accounting office regarding payment of fines, restitution and fees imposed. Abide by the financial conditions of probation document furnished to you by the court, probation officer or Department of Justice collection agent.
- Forfeit all game, weapons and items seized in all counts
- Pay restitution in an amount to be determined as ordered and pursuant to ORS 137.106(b). Defense stipulates the State does not need to detail the nature and amount of economic damages at this time.

### **Count 5 : Wildlife Violation**

Count number 5 , Wildlife Violation, 498002, Misdemeanor Unclassified, committed on or about 02/12/2012. Conviction is based upon a Guilty Plea on 02/12/2014.

#### **Incarceration**

Defendant is sentenced to the custody of County Jail, for a period of 30 day(s). Defendant is remanded to the custody of the Jackson County Sheriff for transportation to the Supervisory Authority for service of this sentence. Defendant may receive credit for time served.

The Defendant may be considered by the supervisory authority for any form of alternative sanction authorized by ORS 423.478, and the Defendant shall pay any required per diem fees.

This sentence shall be concurrent with the following cases 14CR00102.

### **Count 6 : Wildlife Violation**

Count number 6 , Wildlife Violation, 498002, Misdemeanor Unclassified, committed on or about 11/06/2011. Conviction is based upon a Guilty Plea on 02/12/2014.

#### **Incarceration**

Defendant is sentenced to the custody of County Jail, for a period of 30 day(s). Defendant is remanded to the custody of the Jackson County Sheriff for transportation to the Supervisory Authority for service of this sentence. Defendant may receive credit for time served.

The Defendant may be considered by the supervisory authority for any form of alternative sanction authorized by ORS 423.478, and the Defendant shall pay any required per diem fees.

This sentence shall be concurrent with the following cases ct 5 and 14cr00102.
