- Obey all laws.
- Abstain from the use of intoxicants; do not consume or possess alcohol or non-prescribed controlled substances
- Enter and successfully complete alcohol/drug treatment as deemed appropriate by probation officer. Report to Jackson County Community Justice, 1101 West Main, Medford, OR 97501.
- Submit to random breath and urine testing if lawfully requested by a police officer.
- No VIP Attendance required

Jail as a Condition of Probation

Defendant is confined to jail for 10 day(s). Defendant is to report to Supervisory Authority by 11/04/2013 at 9:00 AM. Defendant may receive credit for time served.

The Defendant may be considered by the supervisory authority for any form of alternative sanction authorized by ORS 423.478, and the defendant shall pay any required per diem fees.
