It is adjudged that the defendant has been convicted on the following count(s):

Count 1 : Fleeing or Attempting to Elude a Police Officer

Count number 1 , Fleeing or Attempting to Elude a Police Officer, 811.540(1)(b)(A), Misdemeanor Class A by Reduced - to A Misdemeanor, committed on or about 11/11/2011. Conviction is based upon a Guilty Plea on 02/27/2013.

Suspended Imposition of Sentence

Imposition of sentence is suspended.

Probation

Defendant is placed on Bench Probation for a period of 18 month(s) and shall be subject to the following conditions of Probation:

Defendant is subject to all general conditions of probation (ORS 137.540).

Furthermore, Defendant is subject to the following Special Conditions of Probation (ORS 137.540(2)): Defendant shall:

- Obey all laws.
- Comply with all conditions and procedures of accounting office regarding payment of fines, restitution and fees imposed. Abide by the financial conditions of probation document furnished to you by the court, probation officer or Department of Justice collection agent.
- No contact with known gang members or associates and do not go to places known to be frequented by gang members. Do not wear gang clothing or possess gang related items of personal property.
- Do not access internet sites (including social networking sites such as Facebook, My Space, etc.) known to be visited by gang members.
- Do not possess firearms, either actual or simulated, ammunition, weapons or dangerous animals.

Jail as a Condition of Probation

Defendant is confined to jail for 1 day(s). Defendant is remanded to the custody of the Jackson County Sheriff for transportation to the Supervisory Authority for service of this sentence. Defendant may receive credit for time served. Time spent to apply.

- Not drive without valid permit, license and insurance.
- Obey all laws.
- Abstain from the use of intoxicants; do not consume or possess alcohol or non-prescribed controlled substances
- Enter and successfully complete alcohol/drug treatment as deemed appropriate by probation officer. Report to Jackson County Community Justice, 1101 West Main, Medford, OR 97501.
- Submit to random breath and urine testing if lawfully requested by a police officer.
- Attend Victims Impact Panel on 11/6/13;

Jail as a Condition of Probation
