It is adjudged that the defendant has been convicted on the following count(s):

Count 1 : Driving Under the Influence of Intoxicants

Count number 1 , Driving Under the Influence of Intoxicants, 813.010(4), Misdemeanor Class A, committed on or about 06/04/2012. Conviction is based upon a Guilty Plea on 10/07/2013.

License Suspension / Revocation

Defendant's Drivers License is Suspended for 1 year(s).

Probation

Defendant is sentenced to Bench Probation for a period of 2 year(s) and shall be subject to the following conditions of Probation:

Defendant is subject to all general conditions of probation (ORS 137.540).

Furthermore, Defendant is subject to the following Special Conditions of Probation (ORS 137.540(2)): Defendant shall:

- Comply with all conditions and procedures of accounting office regarding payment of fines, restitution and fees imposed. Abide by the financial conditions of probation document furnished to you by the court, probation officer or Department of Justice collection agent.
- Not drive without valid permit, license and insurance.
- Obey all laws.
- Abstain from the use of intoxicants; do not consume or possess alcohol or non-prescribed controlled substances
- Enter and successfully complete alcohol/drug treatment as deemed appropriate by probation officer. Report to Jackson County Community Justice, 1101 West Main, Medford, OR 97501.
- Submit to random breath and urine testing if lawfully requested by a police officer.
- Attend Victims Impact Panel on 11/6/13.

Jail as a Condition of Probation

Defendant is confined to jail for 20 day(s). Defendant is remanded to the custody of the Jackson County Sheriff for transportation to the Supervisory Authority for service of this sentence. DEFENDANT WILL NOT REPORT, CREDIT TIME SERVED. Defendant may receive credit for time served.

The Defendant may be considered by the supervisory authority for any form of alternative sanction authorized by ORS 423.478, and the defendant shall pay any required per diem fees.
