Count 1 : Assault in the Fourth Degree

Count number 1 , Assault in the Fourth Degree, 163.160(2), Misdemeanor Class A, committed on or about 03/06/2012. Conviction is based upon a Jury Verdict of Guilty on 11/21/2013.

Probation

Defendant is sentenced to Bench Probation for a period of 18 month(s) and shall be subject to the following conditions of Probation:
