It is adjudged that the defendant has been convicted on the following count(s):

Count 1 : Driving Under the Influence of Intoxicants

Count number 1 , Driving Under the Influence of Intoxicants, 813.010(4), Misdemeanor Class A, committed on or about 08/26/2012. Conviction is based upon a Jury Verdict of Guilty on March 5, 2014.

Jail as a Condition of Probation
