Count 2 : Possession of Heroin

Count number 2 , Possession of Heroin, 475.854, Felony Class B, committed on or about 09/07/2012. Conviction is based upon a Guilty Plea on 03/10/2014.

- Submit to random breath and urine testing if lawfully requested by a police officer.
- Be allowed to complete probation in Douglas County.

Count 4 : Possession of Methamphetamine
