**COUNT(S)**

It is adjudged that the defendant has been convicted on the following count(s):

**Count 4 : Sexual Abuse in the Third Degree**

Count number 4 , Sexual Abuse in the Third Degree, 163.415, Misdemeanor Class A, committed on or about 08/01/2012. Conviction is based upon a Guilty Plea on 10/31/2013.

**Probation**

Defendant is sentenced to Bench Probation for a period of 5 year(s) and shall be subject to the following conditions of Probation:

Defendant is subject to all general conditions of probation (ORS 137.540).

Furthermore, Defendant is subject to the following Special Conditions of Probation (ORS 137.540(2)):

Defendant shall:

- Obey all laws.
- Comply with all conditions and procedures of accounting office regarding payment of fines, restitution and fees imposed. Abide by the financial conditions of probation document furnished to you by the court, probation officer or Department of Justice collection agent.
- Pay for victim counseling costs.
- Complete 80 hours of community service. Immediately report to Jackson County Community Justice, 1101 West Main, Medford, OR 97501.
- no contact with minors without permission of treatment provider except in the course of employment
- Pay restitution in an amount to be determined as ordered and pursuant to ORS 137.106(b). Defense stipulates the State does not need to detail the nature and amount of economic damages at this time.
- No contact with victim without prior permission from treatment provider and Court.
- Submit to sex offender evaluation, participate in and successfully complete sex offender treatment if deemed appropriate by probation officer.
- No contact with victims residence with out permission of treatment provider
- Pursuant to ORS 181.830, defendant meets the eligibility requirements for relief from registration because the age difference between defendant and the alleged victim is less than 5 years.
