Count 1 : Possession of Methamphetamine

Count number 1 , Possession of Methamphetamine, 475.894, Felony Class C, committed on or about 11/17/2012. Conviction is based upon a Guilty Plea on 08/13/2013.

Incarceration

Defendant is sentenced to the custody of County Jail, for a period of 10 day(s). Defendant is remanded to the custody of the Jackson County Sheriff for transportation to the Supervisory Authority for service of this sentence. Defendant may receive credit for time served. credit from this arrest.
