It is adjudged that the defendant has been convicted on the following count(s):

Count 2 : Burglary in the First Degree

Count number 2 , Burglary in the First Degree, 164.225, Felony Class A, committed on or about 08/03/2012. Conviction is based upon a Guilty Plea on 10/07/2013.

Sentencing Guidelines

The Crime Severity Classification (CSC) on Count Number 2 is 7 and the Criminal History Classification (CHC) is E.

This sentence is pursuant to the following special factors:

- Sentence per ORS 137.717

The court finds substantial and compelling reason for a Downward Dispositional Departure, as stated on the record. This departure is pursuant to the following aggravating or mitigating factor(s):

- Offender Cooperated With State

Probation

Defendant is sentenced to Supervised Probation for a period of 3 year(s) and shall be subject to the following conditions of Probation:

Defendant is subject to all general conditions of probation (ORS 137.540).

Furthermore, Defendant is subject to the following Special Conditions of Probation (ORS 137.540(2)):

Defendant shall:

- Supervised Probation: Report immediately to Jackson County Community Justice, 1101 West Main, Medford, OR 97501 within 24 hours of your sentencing unless you are in custody. If in custody, report within 24 hours of your release from jail.
- Obey all laws.
- Comply with all conditions and procedures of accounting office regarding payment of fines, restitution and fees imposed. Abide by the financial conditions of probation document furnished to you by the court, probation officer or Department of Justice collection agent.
- Not have contact with victim or residence without prior permission from the court.

Jail as a Condition of Probation

Defendant is confined to jail for 30 day(s). Defendant is to report to by 10/17/2013 at 9:00 AM. Defendant may receive credit for time served.

The Defendant may be considered by the supervisory authority for any form of alternative sanction authorized by ORS 423.478, and the defendant shall pay any required per diem fees.

Count # 1 , Theft in the First Degree is Dismissed.

Count # 3 , Criminal Trespass in the First Degree is Dismissed.

Count # 4 , Theft in the Second Degree is Dismissed.
