**COUNT(S)**

It is adjudged that the defendant has been convicted on the following count(s):

**Count 1 : Unlawful Possession of a Firearm**

Count number 1 , Unlawful Possession of a Firearm, 166.250, Misdemeanor Class A, committed on or about 01/28/2013. Conviction is based upon a Guilty Plea on 01/06/2014.

**Probation**

Defendant is sentenced to Bench Probation for a period of 18 month(s) and shall be subject to the following conditions of Probation:

Defendant is subject to all general conditions of probation (ORS 137.540).

Furthermore, Defendant is subject to the following Special Conditions of Probation (ORS 137.540(2)): Defendant shall:

- Obey all laws.
- Comply with all conditions and procedures of accounting office regarding payment of fines, restitution and fees imposed. Abide by the financial conditions of probation document furnished to you by the court, probation officer or Department of Justice collection agent.
- Name: Sarah Smart Not have contact with victim without prior permission from the court.
- Not have contact with victim's residence without the permission of the court.
- Not possess weapons, firearms or dangerous animals.

**Jail as a Condition of Probation**

Defendant is confined to jail for 1 day(s). Defendant is remanded to the custody of the Jackson County Sheriff for transportation to the Supervisory Authority for service of this sentence. Defendant may receive credit for time served.

The Defendant may be considered by the supervisory authority for any form of alternative sanction authorized by ORS 423.478, and the defendant shall pay any required per diem fees.
