COUNT(S)

It is adjudged that the defendant has been convicted on the following count(s):

Count 2 : Delivery of Methamphetamine

Count number 2 , Delivery of Methamphetamine, 475.890(2), Felony Class B, committed on or about 02/27/2013. Conviction is based upon a Guilty Plea on 11/04/2013.

Sentencing Guidelines

The Crime Severity Classification (CSC) on Count Number 2 is 8 and the Criminal History Classification (CHC) is G.

The court finds substantial and compelling reason for a Downward Dispositional Departure, as stated on the record. This departure is pursuant to the following aggravating or mitigating factor(s):

- Same as Optional Probation Criteria

License Suspension / Revocation

Defendant's Driver License is not suspended.

Probation

Defendant is sentenced to Supervised Probation for a period of 3 year(s) and shall be subject to the following conditions of Probation:

Defendant is subject to all general conditions of probation (ORS 137.540).

Furthermore, Defendant is subject to the following Special Conditions of Probation (ORS 137.540(2)): Defendant shall:

- Supervised Probation: Report immediately to Jackson County Community Justice, 1101 West Main, Medford, OR 97501 within 24 hours of your sentencing unless you are in custody. If in custody, report within 24 hours of your release from jail.
- Comply with all conditions and procedures of accounting office regarding payment of fines, restitution and fees imposed. Abide by the financial conditions of probation document furnished to you by the court, probation officer or Department of Justice collection agent.
- Not have contact with users of controlled substances.
- Abstain from use or possession of controlled substances.
- Refrain from knowingly associating with persons who use or possess controlled substances, or from frequenting places where such substances are kept or sold.
- Obey all laws.
- Submit to random blood, breath and urine testing at the direction of probation officer to determine compliance with conditions of supervision; results are useable at revocation proceedings.
- Submit to search by probation officer of person or premises pursuant to ORS 137.540(i).
- Enter and successfully complete alcohol/drug treatment as deemed appropriate by probation officer. Report to Jackson County Community Justice, 1101 West Main, Medford, OR 97501.
- Submit to random breath and urine testing if lawfully requested by a police officer.

Jail as a Condition of Probation

Defendant is confined to jail for 3 day(s). Defendant is to report to by 11/04/2013. Defendant may receive credit for time served. will not report credit for time served.

The Defendant may be considered by the supervisory authority for any form of alternative sanction authorized by ORS 423.478, and the defendant shall pay any required per diem fees.

Count # 1 , Manufacture of Methamphetamine is Dismissed.

Count # 3 , Possession of Methamphetamine is Dismissed.
