It is adjudged that the defendant has been convicted on the following count(s):

**Count 1 : Identity Theft**

Count number 1, Identity Theft, 165.800, Felony Class C, committed on or about 04/03/2013. Conviction is based upon a Guilty Plea on 09/25/2013.

**Sentencing Guidelines**

The Crime Severity Classification (CSC) on Count Number 1 is 2 and the Criminal History Classification (CHC) is E.

- Not have contact with Dale Wilkes, victim without prior permission from the court.
