Probation

Defendant is sentenced to Bench Probation for a period of 11 month(s) and shall be subject to the following conditions of Probation:

Defendant is subject to all general conditions of probation (ORS 137.540).

Furthermore, Defendant is subject to the following Special Conditions of Probation (ORS 137.540(2)): Defendant shall:

- Comply with all conditions and procedures of accounting office regarding payment of fines, restitution and fees imposed. Abide by the financial conditions of probation document furnished to you by the court, probation officer or Department of Justice collection agent.
- Obey all laws.
- Pay restitution in an amount to be determined as ordered and pursuant to ORS 137.106(b). Defense stipulates the State does not need to detail the nature and amount of economic damages at this time.
- restitution on all counts including dismissed counts
- Complete 24 hours of community service. Immediately report to Jackson County Community Justice, 1101 West Main, Medford, OR 97501.
- Report to the Jackson County Jail to complete processing; finger prints and photograph.
