It is adjudged that the defendant has been convicted on the following count(s):

Count 2 : Delivery of Methamphetamine

Count number 2, Delivery of Methamphetamine, 475.890(2), Felony Class B, committed on or about 01/18/2013. Conviction is based upon a Guilty Plea on 10/08/2013.

Sentencing Guidelines

The Crime Severity Classification (CSC) on Count Number 2 is 8 and the Criminal History Classification (CHC) is E.

Probation

- Obey all laws.
- Comply with all conditions and procedures of accounting office regarding payment of fines, restitution and fees imposed. Abide by the financial conditions of probation document furnished to you by the court, probation officer or Department of Justice collection agent.
- Supervised Probation: Report immediately to Jackson County Community Justice, 1101 West Main, Medford, OR 97501 within 24 hours of your sentencing unless you are in custody. If in custody, report within 24 hours of your release from jail.
- Comply with all requirements of Drug Court.

Furthermore, Defendant is subject to the following Special Conditions of Probation (ORS 137.540(2)): Defendant shall:

- Comply with all conditions and procedures of accounting office regarding payment of fines, restitution and fees imposed. Abide by the financial conditions of probation document furnished to you by the court, probation officer or Department of Justice collection agent.
- Not drive without valid permit, license and insurance.
- Obey all laws.
- Abstain from the use of intoxicants; do not consume or possess alcohol or non-prescribed controlled substances
- Enter and successfully complete alcohol/drug treatment as deemed appropriate by probation officer. Report to Jackson County Community Justice, 1101 West Main, Medford, OR 97501.
- Submit to random breath and urine testing if lawfully requested by a police officer.
- Attend Victims Impact Panel on 10/2/13.

Jail as a Condition of Probation

Defendant is confined to jail for 20 day(s). Defendant is to report to Supervisory Authority by 09/30/2013 at 9:00 AM. Defendant may receive credit for time served.

The Defendant may be considered by the supervisory authority for any form of alternative sanction authorized by ORS 423.478, and the defendant shall pay any required per diem fees.
