COUNT(S)

It is adjudged that the defendant has been convicted on the following count(s):

Count 1 : Possession of Methamphetamine

Count number 1, Possession of Methamphetamine, 475.894, Felony Class C, committed on or about 05/02/2013. Conviction is based upon a Guilty Plea on 09/10/2013.

Sentencing Guidelines

The Crime Severity Classification (CSC) on Count Number 1 is 1 and the Criminal History Classification (CHC) is A.

License Suspension / Revocation

Defendant's Driver License is not suspended.

Probation

Defendant is sentenced to Supervised Probation for a period of 18 month(s) and shall be subject to the following conditions of Probation:

Defendant is subject to all general conditions of probation (ORS 137.540).

Furthermore, Defendant is subject to the following Special Conditions of Probation (ORS 137.540(2)): Defendant shall:

- Obey all laws.
- Comply with all conditions and procedures of accounting office regarding payment of fines, restitution and fees imposed. Abide by the financial conditions of probation document furnished to you by the court, probation officer or Department of Justice collection agent.
- If selected, the defendant will comply with all requirements of treatment courts.

Count 2 : Felon in Possession of a Restricted Weapon

Count number 2, Felon in Possession of a Restricted Weapon, 166.270(2), Misdemeanor Class A, committed on or about 05/02/2013. Conviction is based upon a Guilty Plea on 09/10/2013.

Incarceration

Defendant is sentenced to the custody of County Jail, for a period of 30 day(s). Defendant is remanded to the custody of the Jackson County Sheriff for transportation to the Supervisory Authority for service of this sentence. Defendant may not receive credit for time served.

The Defendant may be considered by the supervisory authority for any form of alternative sanction authorized by ORS 423.478, and the Defendant shall pay any required per diem fees.

If convicted of a felony or a crime involving domestic violence, you may lose the right to buy, sell, transport, receive, or possess a firearm, ammunition, or other weapons in both personal and professional endeavors pursuant to ORS 166.250, ORS 166.291, ORS 166.300, and/or 18 USC 922(g).
