It is adjudged that the defendant has been convicted on the following count(s):

Count 1 : Driving Under the Influence of Intoxicants

Count number 1, Driving Under the Influence of Intoxicants, 813.010(4), Misdemeanor Class A, committed on or about 04/13/2013. Conviction is based upon a Guilty Plea on 09/09/2013.

License Suspension / Revocation

- Pay restitution in an amount to be determined as ordered and pursuant to ORS 137.106(b). Defense stipulates the State does not need to detail the nature and amount of economic damages at this time.
- RESTITUTION TO BE ON ALL COUNTS INCLUDING THOSE DISMISSED.
