



## **License Suspension / Revocation**

Defendant's Driver License is not suspended.

## **Probation**

Defendant is sentenced to Supervised Probation for a period of 3 year(s) and shall be subject to the following conditions of Probation:

Defendant is subject to all general conditions of probation (ORS 137.540).

Furthermore, Defendant is subject to the following Special Conditions of Probation (ORS 137.540(2)): Defendant shall:

- Supervised Probation: Report immediately to Jackson County Community Justice, 1101 West Main, Medford, OR 97501 within 24 hours of your sentencing unless you are in custody. If in custody, report within 24 hours of your release from jail.
- Comply with all conditions and procedures of accounting office regarding payment of fines, restitution and fees imposed. Abide by the financial conditions of probation document furnished to you by the court, probation officer or Department of Justice collection agent.
- Not have contact with users of controlled substances.
- Abstain from use or possession of controlled substances.
- Refrain from knowingly associating with persons who use or possess controlled substances, or from frequenting places where such substances are kept or sold.
- Obey all laws.
- Submit to random blood, breath and urine testing at the direction of probation officer to determine compliance with conditions of supervision; results are useable at revocation proceedings.
- Submit to search by probation officer of person or premises pursuant to ORS 137.540(i).
- Enter and successfully complete alcohol/drug treatment as deemed appropriate by probation officer. Report to Jackson County Community Justice, 1101 West Main, Medford, OR 97501.
- Submit to random breath and urine testing if lawfully requested by a police officer.

Pursuant to the sentencing guidelines grid, the Defendant is subject to 180 sanction units with 90 jail units.

## **Count 3 : Child Neglect in the First Degree**

Count number 3, Child Neglect in the First Degree, 163.547, Felony Class B, committed on or about 12/11/2012. Conviction is based upon a Guilty Plea on 09/30/2013.

## **Sentencing Guidelines**

The Crime Severity Classification (CSC) on Count Number 3 is 6 and the Criminal History Classification (CHC) is I.

## **Probation**

### **Jail as a Condition of Probation**

Defendant is confined to jail for 12 day(s). Defendant is to report to Supervisory Authority by 09/30/2013.  
DEFENDANT WILL NOT REPORT, CREDIT TIME SERVED. Defendant may receive credit for time served.

The Defendant may be considered by the supervisory authority for any form of alternative sanction authorized by ORS 423.478, and the defendant shall pay any required per diem fees.

Count # 1, Manufacture of Marijuana is Dismissed.

If convicted of a felony or a crime involving domestic violence, you may lose the right to buy, sell, transport, receive, or possess a firearm, ammunition, or other weapons in both personal and professional endeavors pursuant to ORS 166.250, ORS 166.291, ORS 166.300, and/or 18 USC 922(g).
