COUNT(S)

It is adjudged that the defendant has been convicted on the following count(s):

Count 1 : Assault in the Fourth Degree - Constituting Domestic Violence

Count number 1, Assault in the Fourth Degree - Constituting Domestic Violence, 163.160(2), Misdemeanor Class A, committed on or about 05/03/2013. Conviction is based upon a No Contest Plea on 09/05/2013.

Suspended Imposition of Sentence

Imposition of sentence is suspended.

Probation

Defendant is placed on Bench Probation for a period of 18 month(s) and shall be subject to the following conditions of Probation:

Defendant is subject to all general conditions of probation (ORS 137.540).

Furthermore, Defendant is subject to the following Special Conditions of Probation (ORS 137.540(2)): Defendant shall:

- Obey all laws.
- Comply with all conditions and procedures of accounting office regarding payment of fines, restitution and fees imposed. Abide by the financial conditions of probation document furnished to you by the court, probation officer or Department of Justice collection agent.
- Not have contact with victim, Rhiannon E. Eppard, without prior permission from the court.
- Abstain from the use of intoxicants; do not consume or possess alcohol or non-prescribed controlled substances

Jail as a Condition of Probation

Defendant is confined to jail for 2 day(s). Defendant is remanded to the custody of the Jackson County Sheriff for transportation to the Supervisory Authority for service of this sentence. Defendant may receive credit for time served. Time spent to apply.

The Defendant may be considered by the supervisory authority for any form of alternative sanction authorized by ORS 423.478, and the defendant shall pay any required per diem fees.
