It is adjudged that the defendant has been convicted on the following count(s):

**Count 1 : Burglary in the First Degree**

Count number 1, Burglary in the First Degree, 164.225, Felony Class A, committed on or about 04/18/2013. Conviction is based upon a Guilty Plea on 09/10/2013.

**Sentencing Guidelines**

The Crime Severity Classification (CSC) on Count Number 1 is 7 and the Criminal History Classification (CHC) is F.

This sentence is pursuant to the following special factors:

## **Probation**

Defendant is sentenced to Supervised Probation for a period of 3 year(s) and shall be subject to the following conditions of Probation:

Defendant is subject to all general conditions of probation (ORS 137.540).

Furthermore, Defendant is subject to the following Special Conditions of Probation (ORS 137.540(2)): Defendant shall:

- Obey all laws.
- Comply with all conditions and procedures of accounting office regarding payment of fines, restitution and fees imposed. Abide by the financial conditions of probation document furnished to you by the court, probation officer or Department of Justice collection agent.
- Pay restitution in an amount to be determined as ordered and pursuant to ORS 137.106(b). Defense stipulates the State does not need to detail the nature and amount of economic damages at this time.
- If selected, the defendant will comply with all requirements of treatment courts.
- Not have contact with, DENNIS KANE, victim without prior permission from the court.
- Not have contact with victim's residence without the permission of the court.
- NO CONTACT WITH BIG R.

Count # 4, Possession of Methamphetamine is Dismissed.
