COUNT(S)

It is adjudged that the defendant has been convicted on the following count(s):

Count 1 : Resisting Arrest

Count number 1, Resisting Arrest, 162.315, Misdemeanor Class A, committed on or about 07/15/2013. Conviction is based upon a No Contest Plea on 09/12/2013.

Probation

Defendant is sentenced to Bench Probation for a period of 18 month(s) and shall be subject to the following conditions of Probation:

Defendant is subject to all general conditions of probation (ORS 137.540).

Furthermore, Defendant is subject to the following Special Conditions of Probation (ORS 137.540(2)): Defendant shall:

- Obey all laws.
- Comply with all conditions and procedures of accounting office regarding payment of fines, restitution and fees imposed. Abide by the financial conditions of probation document furnished to you by the court, probation officer or Department of Justice collection agent.
- Pay restitution in an amount to be determined as ordered and pursuant to ORS 137.106(b). Defense stipulates the State does not need to detail the nature and amount of economic damages at this time.
- Abstain from the use of intoxicants; do not consume or possess alcohol or non-prescribed controlled substances
- Pay restitution on all count(s), including those dismissed

Jail as a Condition of Probation

Defendant is confined to jail for 10 day(s). Defendant is remanded to the custody of the Jackson County Sheriff for transportation to the Supervisory Authority for service of this sentence. Defendant may receive credit for time served.

The Defendant may be considered by the supervisory authority for any form of alternative sanction authorized by ORS 423.478, and the defendant shall pay any required per diem fees.

COUNTS DISPOSED WITH NO CONVICTION

Count # 2, Criminal Mischief in the Second Degree is Dismissed.

Count # 3, Harassment is Dismissed.

Count # 4, Disorderly Conduct in the Second Degree is Dismissed.
