**COUNT(S)**

It is adjudged that the defendant has been convicted on the following count(s):

**Count 1 : Identity Theft**

Count number 1, Identity Theft, 165.800, Felony Class C, committed on or about 06/20/2013. Conviction is based upon a Guilty Plea on 10/01/2013.

**Sentencing Guidelines**

The Crime Severity Classification (CSC) on Count Number 1 is 2 and the Criminal History Classification (CHC) is C.

The court finds substantial and compelling reason for a Downward Dispositional Departure, as stated on the record. This departure is pursuant to the following aggravating or mitigating factor(s):

- Stipulation of the parties.

**Probation**

Defendant is sentenced to Bench Probation for a period of 18 month(s) and shall be subject to the following conditions of Probation:

Defendant is subject to all general conditions of probation (ORS 137.540).

Furthermore, Defendant is subject to the following Special Conditions of Probation (ORS 137.540(2)): Defendant shall:

- Obey all laws.
- Comply with all conditions and procedures of accounting office regarding payment of fines, restitution and fees imposed. Abide by the financial conditions of probation document furnished to you by the court, probation officer or Department of Justice collection agent.
- Complete 80 hours of community service. Immediately report to Jackson County Community Justice, 1101 West Main, Medford, OR 97501.
- Not have contact with victim, Richard Wright, without prior permission from the court.
- Not have contact with victim's residence without the permission of the court.

Pursuant to the sentencing guidelines grid, the Defendant is subject to 90 sanction units with 30 jail units.
