It is adjudged that the defendant has been convicted on the following count(s):

Count 2 : Endangering the Welfare of a Minor

Count number 2, Endangering the Welfare of a Minor, 163.575(2), Misdemeanor Class A, committed on or about 07/23/2013. Conviction is based upon a Guilty Plea on 09/25/2013.

Suspended Imposition of Sentence

Imposition of sentence is suspended.

Jail as a Condition of Probation

Defendant is confined to jail for 19 day(s). Defendant is remanded to the custody of the Jackson County Sheriff for transportation to the Supervisory Authority for service of this sentence. Defendant may receive credit for time served. Time spent to apply.
