Defendant was assisted by interpreter, Jeanette Poston.

COUNT(S)

It is adjudged that the defendant has been convicted on the following count(s):

Count 1 : Driving Under the Influence of Intoxicants

Count number 1, Driving Under the Influence of Intoxicants, 813.010(5), Felony Class C, committed on or about 06/04/2013. Conviction is based upon a Guilty Plea on 09/26/2013.

Sentencing Guidelines

The Crime Severity Classification (CSC) on Count Number 1 is 4 and the Criminal History Classification (CHC) is A.

The court finds substantial and compelling reason for a Downward Dispositional Departure, as stated on the record. This departure is pursuant to the following aggravating or mitigating factor(s):

- Stipulation of the parties

License Suspension / Revocation

Defendant's Drivers License is Revoked for Permanent.

Probation

Defendant is sentenced to Supervised Probation for a period of 2 year(s) and shall be subject to the following conditions of Probation:

Defendant is subject to all general conditions of probation (ORS 137.540).

Furthermore, Defendant is subject to the following Special Conditions of Probation (ORS 137.540(2)): Defendant shall:

- Comply with all conditions and procedures of accounting office regarding payment of fines, restitution and fees imposed. Abide by the financial conditions of probation document furnished to you by the court, probation officer or Department of Justice collection agent.
- Not drive without valid permit, license and insurance.
- Obey all laws.
- Abstain from the use of intoxicants; do not consume or possess alcohol or non-prescribed controlled substances
- Enter and successfully complete alcohol/drug treatment as deemed appropriate by probation officer. Report to Jackson County Community Justice, 1101 West Main, Medford, OR 97501.
- Submit to random breath and urine testing if lawfully requested by a police officer.
- Attend Victims Impact Panel on 12-04-13
- Supervised Probation: Report immediately to Jackson County Community Justice, 1101 West Main, Medford, OR 97501 within 24 hours of your sentencing unless you are in custody. If in custody, report within 24 hours of your release from jail.
- Attend and participate with any counseling deemed appropriate by probation officer.
- No contact with Leeja Rae Henney without written permission from Probation Officer.

Jail as a Condition of Probation

Defendant is confined to jail for 120 day(s). Defendant is remanded to the custody of the Jackson County Sheriff for transportation to the Supervisory Authority for service of this sentence. Defendant may receive credit for time served.

The Defendant may be considered by the supervisory authority for any form of alternative sanction authorized by ORS 423.478, and the defendant shall pay any required per diem fees.
