Defendant appeared in person and was in custody. The court determined that the defendant was indigent for purposes of court-appointed counsel, and the court appointed counsel for the defendant. COUNT(S)

It is adjudged that the defendant has been convicted on the following count(s):

Count 1 : Robbery in the Third Degree

Count number 1, Robbery in the Third Degree, 164.395, Felony Class C, committed on or about 08/25/2013. Conviction is based upon a Guilty Plea on 09/12/2013.

Sentencing Guidelines

The Crime Severity Classification (CSC) on Count Number 1 is 5 and the Criminal History Classification (CHC) is E.

This sentence is pursuant to the following special factors:

- Sentence per ORS 137.717

Sentence Instructions

Defendant shall:

- Comply with all conditions and procedures of accounting office regarding payment of fines, restitution and fees imposed. Abide by the financial conditions of probation document furnished to you by the court, probation officer or Department of Justice collection agent.
- Pay restitution in an amount to be determined as ordered and pursuant to ORS 137.106(b). Defense stipulates the State does not need to detail the nature and amount of economic damages at this time.

Incarceration

Defendant is sentenced to the custody of Oregon Dept of Corrections, for a period of 18 month(s). Defendant is remanded to the custody of the Jackson Sheriff for transportation to the Oregon Dept of Corrections for service of this sentence. CREDIT FROM DATE OF MOST RECENT ARREST. Defendant may receive credit for time served.

The Defendant may be considered by the executing or releasing authority for any form of reduction in sentence, temporary leave from custody, work release, or program of conditional or supervised release authorized by law for which the Defendant is otherwise eligible at the time of sentencing. The Defendant may not be considered for release on post-prison supervision under ORS 421.508(4) upon successful completion of an alternative incarceration program.

Post-Prison Supervision

The term of Post-Prison Supervision is 2 year(s). If the Defendant violates any of the conditions of post-prison supervision, the defendant shall be subject to sanctions including the possibility of additional imprisonment in accordance with the rules of the State Sentencing Guidelines Board. The court recommends as a condition of post-prison supervision:

Count 4 : Theft in the Second Degree

Count number 4, Theft in the Second Degree, 164.045, Misdemeanor Class A, committed on or about 08/25/2013. Conviction is based upon a Guilty Plea on 09/12/2013.

Incarceration

Defendant is sentenced to the custody of County Jail, for a period of 22 day(s). Defendant is remanded to the custody of

the Jackson County Sheriff for transportation to the Supervisory Authority for service of this sentence. CREDIT FROM DATE OF MOST RECENT ARREST. Defendant may receive credit for time served.

The Defendant may be considered by the supervisory authority for any form of alternative sanction authorized by ORS 423.478, and the Defendant shall pay any required per diem fees.

COUNTS DISPOSED WITH NO CONVICTION

Count # 2, Robbery in the Third Degree is Dismissed.

Count # 3, Criminal Mischief in the First Degree is Dismissed.

If convicted of a felony or a crime involving domestic violence, you may lose the right to buy, sell, transport, receive, or possess a firearm, ammunition, or other weapons in both personal and professional endeavors pursuant to ORS 166.250, ORS 166.291, ORS 166.300, and/or 18 USC 922(g).
