Defendant appeared in person and was in custody. The court determined that the defendant was indigent for purposes of court-appointed counsel, and the court appointed counsel for the defendant. The defendant was represented by Attorney(s) ALYSSA R BARTHOLOMEW, OSB Number 051649. Plaintiff appeared by and through Attorney(s) TERRY J SMITH-NORTON, OSB Number 913225.

**COUNT(S)**

It is adjudged that the defendant has been convicted on the following count(s):

**Count 1 : Burglary in the First Degree**

Count number 1, Burglary in the First Degree, 164.225, Felony Class A, committed on or about 09/14/2013. Conviction is based upon a Guilty Plea on 10/11/2013.

**Sentencing Guidelines**

The Crime Severity Classification (CSC) on Count Number 1 is 7 and the Criminal History Classification (CHC) is G.

**Probation**

Defendant is sentenced to Supervised Probation for a period of 3 year(s) and shall be subject to the following conditions of Probation:

Defendant is subject to all general conditions of probation (ORS 137.540).

Furthermore, Defendant is subject to the following Special Conditions of Probation (ORS 137.540(2)): Defendant shall:

- Obey all laws.
- Comply with all conditions and procedures of accounting office regarding payment of fines, restitution and fees imposed. Abide by the financial conditions of probation document furnished to you by the court, probation officer or Department of Justice collection agent.
- Attend and participate with any counseling deemed appropriate by probation officer.
- Pay restitution in an amount to be determined as ordered and pursuant to ORS 137.106(b). Defense stipulates the State does not need to detail the nature and amount of economic damages at this time.
- Not have contact with victim without prior permission from the court.
- Not have contact with victim's residence without the permission of the court.

Pursuant to the sentencing guidelines grid, the Defendant is subject to 180 sanction units with 90 jail units.

**Jail as a Condition of Probation**

Defendant is confined to jail for 20 day(s). Defendant is remanded to the custody of the Jackson County Sheriff for transportation to the Supervisory Authority for service of this sentence. Defendant may receive credit for time served.

The Defendant may be considered by the supervisory authority for any form of alternative sanction authorized by ORS 423.478, and the defendant shall pay any required per diem fees.
