**COUNT(S)**

It is adjudged that the defendant has been convicted on the following count(s):

**Count 2 : Failure to Report as a Sex Offender**

Count number 2, Failure to Report as a Sex Offender, 181.599(3)(b), Felony Class C, committed on or about 09/24/2013. Conviction is based upon a Guilty Plea on 10/07/2013.

**Sentencing Guidelines**

The Crime Severity Classification (CSC) on Count Number 2 is 4 and the Criminal History Classification (CHC) is C.

**Probation**

Defendant is sentenced to Supervised Probation for a period of 2 year(s) and shall be subject to the following conditions of Probation:

Defendant is subject to all general conditions of probation (ORS 137.540).

Furthermore, Defendant is subject to the following Special Conditions of Probation (ORS 137.540(2)): Defendant shall:

- Obey all laws.
- Comply with all conditions and procedures of accounting office regarding payment of fines, restitution and fees imposed. Abide by the financial conditions of probation document furnished to you by the court, probation officer or Department of Justice collection agent.
- register as sex offender as required
- Supervised Probation: Report immediately to Jackson County Community Justice, 1101 West Main, Medford, OR 97501 within 24 hours of your sentencing unless you are in custody. If in custody, report within 24 hours of your release from jail.

### **Jail as a Condition of Probation**

Defendant is confined to jail for 10 day(s). Defendant is remanded to the custody of the Jackson County Sheriff for transportation to the Supervisory Authority for service of this sentence. Defendant may receive credit for time served.

The Defendant may be considered by the supervisory authority for any form of alternative sanction authorized by ORS 423.478, and the defendant shall pay any required per diem fees.

For the reasons stated on the record, this sentence shall be consecutive to the sentence(s) on the following cases: 13cr00939, 13cr02936, 13cr05771, 13cr05706

Count # 1, Possession of Methamphetamine is Dismissed.

Count # 3, Criminal Driving While Suspended is Dismissed.
