It is adjudged that the defendant has been convicted on the following count(s):

**Count 2 : Assault in the Fourth Degree**

Count number 2, Assault in the Fourth Degree, 163.160(2), Misdemeanor Class A, committed on or about 03/02/2013. Conviction is based upon a Guilty Plea on 09/23/2013.

**Probation**

Defendant is sentenced to Bench Probation for a period of 11 month(s) and shall be subject to the following conditions of Probation:

Defendant is subject to all general conditions of probation (ORS 137.540).

Furthermore, Defendant is subject to the following Special Conditions of Probation (ORS 137.540(2)): Defendant shall:

- Obey all laws.
- Not have contact with victim or residence without prior permission from the court.
