ORDER ESTABLISHING THE TERMS
OF THE PETIT and GRAND JURIES
AND MANNER OF THEIR SELECTION

WHEREAS, ORS 10.205 to 10.265, which govern the selecting and summoning of jurors, require the jury selection process be completed pursuant to the ORDER of the Presiding Judge,


NOW, THEREFORE, IT IS HEREBY ORDERED that the jury terms in the Sixth Judicial District for calendar year 2012 are established as follows:

1. The terms of the petit jury in Umatilla County shall be established as follows: Monthly, beginning January 1, 2012 and continuing through December 31, 2012.
2. The terms of the petit jury in Morrow County shall be established as follows:
 - a. January 1, 2012 through March 31, 2012;
 - b. April 1, 2012 through June 30, 2012;
 - c. July 1, 2012 through September 30, 2012; and
 - d. October 1, 2012 through December 31, 2012.
3. The Trial Court Administrator shall select term jurors from the master jury list procured from the State Court Administrator's office pursuant to ORS 10.215 for each county.
 - a. For each term of the petit jury in Umatilla County, a total of 1,200 jurors are selected at random from the Umatilla County master jury list.
 - b. For each term of the petit jury in Morrow County, a total of 350 jurors are selected at random from the Morrow County master jury list.
 - c. Each term jury list shall contain, at minimum, the first name, the surname, and the place of residence of each juror selected for that term.
 - d. The term jury list for each term in each county shall be certified by the Trial Court Administrator, or designee, and placed on file in the Circuit Court for each county pursuant to ORS 10.255(4).

IT IS ALSO HEREBY ORDERED that the grand jury terms in the Sixth Judicial District for calendar year 2012 are established as follows:

4. The terms of the grand jury in Umatilla County shall be established as follows:
 - a. January 1, 2012 through March 31, 2012;
 - b. April 1, 2012 through June 30, 2012;
 - c. July 1, 2012 through September 30, 2012; and
 - d. October 1, 2012 through December 31, 2012.
5. The terms of the grand jury for Morrow County shall be established as follows:
 - a. January 1, 2012 through March 31, 2012;
 - b. April 1, 2012 through June 30, 2012;
 - c. July 1, 2012 through September 30, 2012; and
 - d. October 1, 2012 through December 31, 2012.
6. The Trial Court Administrator shall select term jurors for the terms of the grand juries from the master jury list procured from the State Court Administrator's office pursuant to ORS 10.215 for each county.
 - a. For each term of the grand jury in Umatilla County, a total of not more than 120 jurors not already selected for the petit jury are selected at random from the Umatilla County master jury list for each term of the grand jury and assigned to the District Attorney for grand jury.
 - b. For each term of the grand jury in Morrow County, a total of 10 jurors are selected at random from the already established term juror list for that term and assigned to the District Attorney for grand jury.
7. The term jury lists described above shall be certified by the Trial Court Administrator, or designee, and placed on file in the Circuit Court for each county pursuant to ORS 10.255(4).
