### **Quick Reference Guide on Reductions**

# Introduction

The OJD Courts payment site allows you to check if your traffic violation is eligible for a reduction in fine. Certain traffic violation cases may be eligible for a reduction based on the type of offense and your driving record.

## It may take up to 10-15 days for a citation to be available for online payment.

OJD Courts ePay service accepts MasterCard and Visa credit and debit cards only. Payments are processed and recorded on your case within 24 hours. A \$1.50 processing fee is assessed per transaction.

## How do I access the OJD Courts ePay site?

The Oregon Courts website home page (<u>www.courts.oregon.gov</u>) contains a **direct link** to the ePay site on the main page or you may choose the **drop-down menu** in the banner under 'How Do I?'

### **Quick Reference Guide on Reductions**

#### How do I check if I'm eligible for reduction?

If your traffic violation type is eligible for reduction, you will be offered the opportunity to check to see if your specific traffic violation is eligible on the next screen.

- a) The "Looking at Your Case" screen will display.
- b) Read all the information on the screen.
- c) Click the checkmark in the blue box to check for a reduction.

**Step 5**: Enter the required cardholder information.

- Select the type of credit card (MasterCard or Visa) from the Card Type selection list.
- Enter the credit card number in the **Card Number** box.
- Select the Exp. Month and Exp. Year from the drop-down lists.
- Enter the credit card three-digit security code (located on the back of the card) in the CVV Code box.
- Enter credit card holder name in the Name on Card box.
- Address Type: US is the default option. For addresses outside the US, select the Foreign option.
- Enter your address in the **Address Line 1** box.
- Enter the city of the address in the City box.
- Select the State from the drop-down list (or enter a State/Province for Foreign address option).
- Enter your zip code in the **ZIP Code** (Postal Code for Foreign address option) box.
- Click Continue.

The Verify Billing Information page opens.

## How do I get a receipt?

**Step 6**: Verify that the billing information is correct, and then click **Process Payment** (continue).

**Note:** If there is incorrect information, click **Back**, and correct any errors. *Repeat Step 5*.



Once the online payment has been approved and successfully processed, a payment confirmation page opens. The payment confirmation page can be printed for use as a receipt of the transaction.
