5. IMPORTANT ORDERS ABOUT THE ORS 539.130(2) INITIAL HEARING

As stated in Case Management Order #7 dated May 28, 2014:

...Exceptions to the ACFFOD must be filed prior to the hearing, pursuant to ORS 539.150(1).

At the October 17, 2014 Initial Hearing, the Court will take the appearances of the parties and other matters as appropriate. The Court does not anticipate argument on the exceptions at the initial hearing. Parties may identify at the Initial Hearing any recommendations for the structure and processing of future proceedings, but will also have the opportunity to make such recommendations in writing after the Initial Hearing [as described in Case Management Order #7.]

IT IS HEREBY ORDERED that all water right claimants in this proceeding and all persons or entities who have filed exceptions shall appear at the October 17, 2014 Initial

Hearing, personally or though counsel. Telephonic appearance, including the ability to speak in the courtroom over the telephone line, shall be allowed at this Initial Hearing, provided that any party or counsel seeking to appear by telephone shall notify Judge Wogan's office, not less than
