

2020 Through the Eyes of a Child Conference Evaluation

Of the 53 attendees at the 2020 Through the Eyes of a Child Conference, 18 completed an online evaluation, for a response rate of 34%.


The results of the evaluation are summarized below:



Respondents were asked to indicate their level of agreement with three statements regarding the Through the Eyes of a Child Conference in general. The graph above indicates the percentage of respondents that agree or strongly agree with the corresponding statement. 100% of respondents thought the presenters were knowledgeable about their topic areas.




Respondents were asked to identify how many years they have presided over juvenile dependency cases. A combined 78% indicated they have presided for less than 5 years.




Respondents were asked to rate each conference session on a scale of 1 (Poor) to 5 (Excellent). These responses were then averaged for each session. The highest rated session (Are You Reasonable in Making Reasonable/Active Efforts Findings?) was 4.7.



Respondents were asked to rate each statement on a scale of 1 (Poor) to 5 (Excellent). These responses were then averaged for each statement. Both statements averaged 4.4 or greater.



Respondents were asked to rate the virtual experience as Better than anticipated, about what was anticipated, or worse than anticipated. A combined 94% of respondents thought the conference was About what was anticipated or Better than anticipated.



Respondents were asked to rate their overall experience at the Through the Eyes of a Child Conference on a scale from 1 (Poor) to 5 (Excellent). 100% of respondents thought the conference was good, very good, or excellent.

What Topics or Format Changes Would You Like to See at Future Conferences?

- 1. Full day is too long for online learning.
- 2. I understand the theory behind breaking us up into small groups for discussion, but in practice, I ended up with only 2 other people in one group and it really limited the range of discussion. Also, the allotted time was pretty short. I would suggest longer and making sure that groups had at least 4 participants.
- 3. I find the technical and legal presentations to be more helpful in my day to day work. The more philosophical aspects of the training is less so.
- 4. ICWA transfer of cases and good cause to deny.
- 5. I think we did the best we could with the format under the circumstances and the zoom breakouts worked really well.
- 6. I miss our people and think we should go back to in-person conferences as soon as possible.
- 7. More time! Always so much material to cover.
- 8. As was mentioned at the conference, the lack of attending in person limited opportunities to consult with peers.
- 9. Practical things to say and do at a hearing when a parent who is present is demonstrably mentally ill.
- 10. I thought the conference went pretty well for a remote experience! I particularly appreciated the opportunity to talk with other judges about their experiences with and suggestions for remote hearings.
