




One gets more than is needed, while the other gets less than is needed. Thus, a huge disparity is created.


The assumption is that everyone benefits from the same supports. This is considered to be equal treatment.



## Enhancing the structure of our system by using data with continuous quality improvement

- Children's Public Private Partnership (CP3), Oregon Social Learning Center (FAIR) and ODHS expand evidencebased practice and services to serve families in Douglas
- CP3 brings together partners to create models to address:
  - Lack of stable housing
  - In-home child safety supports
- FAIR program helps parents with:
  - Substance use
  - Mental Health
  - Parenting
  - Ancillary needs



#### **Prevention and beyond**

- Supporting a larger family serving system
- Expanding services to older youth and young adults
- Knowing and supporting your community



#### How can we work together towards family preservation?

- If successful, the goal is healthy, thriving families with no child welfare or court involvement
- Working to advocate for change in statute to support changing policy and practice
- If a family is court involved, using a family preservation approach with us
- Language (i.e. shared understanding of language around safety)
- Regular shared spaces and places to communicate feedback/ideas
- Family voice at all points of practice
