FAMILY LAW RESOURCES LIST

You have spent money to buy paperwork to file for Divorce, Custody or Modification of Custody, Parenting Time, and/or Child Support. If you hired an attorney, he or she would prepare these forms for you, but you are acting as your own attorney and filling out this paperwork.

Please read and follow all of the instructions carefully. Make sure all of the documents required in the instructions are filled out and included with your Petition, Motion, or Response. The Court might not accept your paperwork if any of the required documents are NOT filled out and attached to the Petition. Be sure to include:

- **Legal Description of Real Property** (e.g., home – usually available from the Tax Assessor for the county where the property is located; you may use form 6N from the Family Law website).
- **Vehicle VIN#s** (you may use form 6N from the Family Law website).
- **If minor children:** Submit a **Parenting Plan** and **Child Support Calculation Worksheets**.

NOTE: If you are filing to modify (change) paperwork that already has an existing case number, include a *certified* copy of the order or judgment you are asking to modify. Confidential information in the judgment must be redacted (blacked out) and included separately on a Confidential Information Form (forms available on Umatilla/Morrow County Family Law page).
