# **Court Ordered Community Service Information**

The organization you choose to perform your COMMUNITY SERVICE hours with must be a NON-PROFIT ORGANIZATION registered with State of Oregon. To confirm whether or not an organization is registered as a non-profit check the State Non-Profit website listed below: http://egov.sos.state.or.us/br/pkg\_web\_name\_srch\_ing.login

Make contact with the organization. Inform the organization that you have Court ordered Community Service to complete. The agency must know the nature of your conviction, the convicted charges and the number of hours ordered.

- Agencies listed below are not obligated to accept any or all community service workers and whether or not you can work there is their decision. If you plan to work at a site that is not on the list, you must provide the information to the Bench Probation Clerk for review and **approval** prior to commencing work.
- Once you have completed the court ordered community service, you must provide the court with proof of hours worked. Verification of hours completed must be on the non-profit agency's letterhead.
