## PROBATION CONDITIONS

Code	Language
ACTP	Enter and successfully complete Anger Management Program.
ALTP	Participate in an alcohol evaluation. Enter and successfully complete any course of treatment, including after and follow-up care determined to be necessary and as designated by the Evaluator or the Probation Officer.
ANTA	Take Antabuse if medically able and directed by the Evaluator, Probation Officer or Treatment Provider and pay all costs.
ATAA	Attend Alcoholics Anonymous meetings.
BFRE	Lump sum payments made through tax refund interception or garnishments will be applied to the support arrearage but do not take the place of the monthly amount you are to pay.
BIPG	Enter into and successfully complete the Batterer Intervention Program.
BOKP	Report to Marion County Correctional Facility for fingerprints and photographs. Following processing at the Marion County Correctional Facility the defendant is ordered to be held in custody.
BORE	Report to Marion County Correctional Facility for fingerprints and photographs. Following processing at the Marion County Correctional Facility the defendant is authorized for released.
CCMTR	Comply with all conditions of Marion County Mental Health Court.
CCTWC	Attend and complete the Sex Buyers Accountability and Diversion Class. No contact with known prostitutes or pimps. No accessing or posting advertisements on any webpage routinely used for the advertisement of prostitution or escort services.
CDRTP	Defendant shall complete the intake process for the 416 program and, if applicable, comply with and complete the 416 program.
CEMDR	If unemployed or employed less than full time, actively seek employment in all fields by submitting at least (5) five applications per week with prospective employers who are accepting applications. Every Friday, you must furnish the Marion County District Attorney, Family Support Division, with a list of the names, addresses, phone numbers and date of contact with the potential employer. CMRC	Maintain safe and sanitary living conditions for children.
CMTR	Comply with the directive(s) of [required text].
CNCCD	Do not have contact with your minor child(ren) unless approved by P.O.
CNCCI	Do not possess, use or communicate the identification, financial records, or Social Security Account Number of any person or entity other than yourself.

NACR	Do not have contact with persons known to be engaged in criminal activities.

NTSA	Obtain permission from Probation Officer prior to engaging in any new financial transaction over \$200 excluding approved rent/mortgage, utilities and food.
NUPB	Do not possess or use a computer or computer generated hardware or data (i.e. memory chips, flash drives, external or portable hard drives or memory cards, data cd's, disks, etc.).
